VENDOR TERMS AND CONDITIONS

1: Exhibitor agrees to follow all city, county, state, and federal laws and regulations. Exhibitors are responsible for obtaining a New Mexico CRS Tax ID and collecting and paying any and all applicable gross receipts tax per the law. Exhibitor must complete the City of Santa Fe Special Event License and return to Promoter by the deadline. Exhibitor further agrees to abide by all rules and regulations imposed by the Venue (Santa Fe Community Convention Center) and the Promoter (Old West Events). This includes COVID-19 related rules and regulations, including any mask mandates or similar. Exhibitor agrees to hold Promoter harmless from any liability or damages arising from the failure of Exhibitor to comply with any applicable laws or regulations.

2: Promoter will provide public security and general liability insurance for the entire show duration. However, Promoter does not accept any responsibility for loss, theft, or damage to any property of the Exhibitor by any cause, nor is Promoter, its officers or agents, to be held accountable or liable for any damages, loss or injury to the person or property of the Exhibitor resulting from any cause, including but not limited to fire, theft, water, or accident. Promoter is not responsible for providing insurance to cover any of the above or for any other purpose. Exhibitors are advised to secure their own individual insurance.

3: In the event the show must be cancelled or relocated, Promoter will not be liable for any claims except for the monies paid to the Promoters for the show that was cancelled or relocated.

4: Promoter reserves the right to determine the eligibility of any Exhibitor or of any product or material to be exhibited. The Exhibitor agrees that any merchandise or material exhibited is represented accurately as to age, condition, and authenticity. No modern firearms may be sold; antique firearms only. Promoter may ask Exhibitor to remove any material from display that is not in keeping with the show, solely at the Promoters' discretion.

5: Deposits and final payments are due as scheduled. Promoter reserves the right to cancel or re-assign any space that has not been properly secured by the deposit and payment schedule.

6: Exhibitor may not sublet, assign, or share booth space without the prior consent of Promoter.

7: By participating in the show, Exhibitor understands and agrees that the Promoter may take, or approve others to take, photographs and/or film of the event for promotional purposes.

8: Exhibitors agree to have completed their set-up by 9:00 am on Saturday, and further agree to not begin packing-up prior to 3:00 pm on Sunday (show close). ANY deviation from this schedule must be approved by Promoter.

9: Per Venue rules, only properly licensed service animals are permitted.

10: Should any legal dispute arise in conjunction with this agreement, all parties agree to abide by the laws of the State of New Mexico

By participating as an Exhibitor, you agree to follow all of the above rules and regulations, and to comport yourself in a professional manner while participating in the show. Failure to abide by any rules or regulations may be cause for termination of your show contract, and/or immediate eviction from the show and/or future shows presented by Old West Events.
